Robbie's Recipes

While Robbie is vacationing, here are two yummy sounding recipe sure to please our very own Terry Steinberg. You might want to try these recipes from the kitchens of Weight Watchers.

SAUCY CHICKEN

Ingredients:

- 2 C chicken broth, divided
- 1/4 C seasoned flour (flour mixed with a dash salt and pepper)
- 4 (4 oz.) skinless, boneless chicken breasts
- 1 can (16 oz.) stewed tomatoes
- 3-4 scallions, chopped

Directions:

1. Pour 1/2 cup of the broth into a wide bowl, place flour mixture on plate. Dip each chicken breast in broth, then flour, turning to coat all sides.
2. Spray 10- or 12-inclu nonstick skillet with nonstick cooking spray; cook chicken over medium heat, turning once, until browned on both sides. Remove chicken from skillet; set aside.
3. Add any remaining flour to skillet; cook, stirring constantly, until browned. Slowly stir in 1/4 cup of the broth, cook until thickened.
4. Add tomatoes and scallions to skillet; bring to a boil. Reduce heat to low, return chicken to skillet and simmer until cooked through, about 10 minutes.

ARTICHOKE AND TOMATO PASTA

Ingredients:

- 6 oz. uncooked bow-tie noodles
 - 1 can (14-16 oz.) artichoke hearts, drained and halved (not oil-packed)
 - 1 C chopped ripe plum tomatoes
 - 1/4 C torn fresh basil leaves
 - 1 T olive oil
 - 1 T lemon juice
 - 1/4 C crumbled feta cheese
- Makes 4 servings.

Directions:

1. Cook noodles according to package directions, rinse under cold running water, drain well, and set aside.
 2. In large bowl, combine remaining ingredients except for cheese; add noodles and toss to coat. Refrigerate for about 1 hour; serve sprinkled with cheese.
- Makes 6 servings.

- In the last fiscal year we incurred expenses of approximately \$137,000, for octagon windows, retaining walls and roofs.
- Paving of portions of our roads is an ongoing process and is being done on a need to be basis. The same holds true for the retaining walls, octagon windows, roofs, landscaping and many other things.
- In the first two months of our fiscal year, we have expended approximately \$44,000 already.
- The HOA Board is closely monitoring the expenses more than ever. The Board has a zero budget for the 2014-2015 year (see column to the right).
- Unaudited expenses exceeded income last year by approximately \$33,000. The audit for the last fiscal year 4/30/2014 has a few final touches by our auditors to be finalized and we're still projecting them to be completed and distributed by the July meeting.

All of Hidden Ridge is invited to try and find alternative cost-saving ideas; please give any suggestions to a board member, in writing, so they may present it to the entire board to be discussed. This is our community and we all need to be involved.

Remember this is our "Jewel" and we need all of Hidden Ridge to keep it shining.

Snacks for a Hot Summer (low calorie and delicious)

The summer months bring temptation for cold, sugary, fun desserts reminiscent of our childhoods...The Good Humor man, Mr. Softee, Italian ices, etc., all of which can bump up your calories and sugar allowance for the day. So, I am suggesting chilling out with sweet treats that cool you off without weighing you down. Now do not expect large or even medium sized portions, SMALL portions must be your rule of thumb! Anything larger will cost you hundreds of calories, especially as we get older; be satisfied with less. Below are some fun and yummy ideas.

1. Lemon raspberry ice cream sandwich: 2 T raspberry sorbet between 2 lemon thins. You can use any sorbet (chocolate) and 2 low fat Graham crackers to change off. (60 cal.-100 cal.)

6. Thick Shake: 4 oz. skim milk, 1/2 banana or 1/3 cup berries, 1/4 cup vanilla low-fat frozen yogurt, tons of crushed ice. Blend till frothy. (100-120 cal.)
7. Any Weight Watchers icicle pop, fudgicle, or frozen fruit bar: (100 - 120 cal.)
8. For anyone who likes a bit of a cocktail - spiked blueberry lemonade: 1/4 cup blueberries blended with 1 T lemon juice, 1 T citrus vodka, 1 cup ice (optional 1 tsp. sugar). (80 cal.)

A Note Regarding Monthly Maintenance Payments

Maintenance payments are due on the 1st of each month. If your payment is received with a postmark after the 15th of the month it is late and a late fee will be added to your account. With the rare exception, no one will receive a waiver for these additional charges.

Here are a few ways to avoid late charges:

1. Set up through your bank for them to automatically send a check from your bank account each month so that it reaches us prior to the 15th. Indicate your unit number in the memo section of the check so that there will not be a need to include the coupon from the maintenance voucher booklet.
2. Prepay for several months at a time. Some of homeowners actually pay the entire year's maintenance charges in January.
3. Prepay by postdating your check. You can also post-date several months at a time. These will be kept in our office and each month, the correct check will be pulled.

Please remember, we are running a business. We have bills that must be paid each month as well! When you are late in paying any other bill, for example a credit card, late fees are imposed!

Would they be adopted by a kind and loving family, or would they face a childhood and adolescence of hard labor and servitude?

As a young Irish immigrant, Vivian Daly was one such child, sent by rail from New York City to an uncertain future a world away. Returning east later in life, Vivian leads a quiet, peaceful existence on the coast of Maine, the memories of her upbringing rendered a hazy blur. But in her attic, hidden in trunks, are vestiges of a turbulent past.

Seventeen-year-old Molly Ayer knows that a community-service position helping an elderly widow clean out her attic is the only thing keeping her out of juvenile hall. But as Molly helps Vivian sort through her keepsakes and possessions, she discovers that she and Vivian aren't as different as they appear. A Penobscot Indian who has spent her youth in and out of foster homes, Molly is also an outsider being raised by strangers, and she, too, has unanswered questions about the past.

Moving between contemporary Maine and Depression-era Minnesota, Orphan Train is a powerful tale of upheaval and resilience, second chances, and unexpected friendship.

3. Furniture and grill under snow

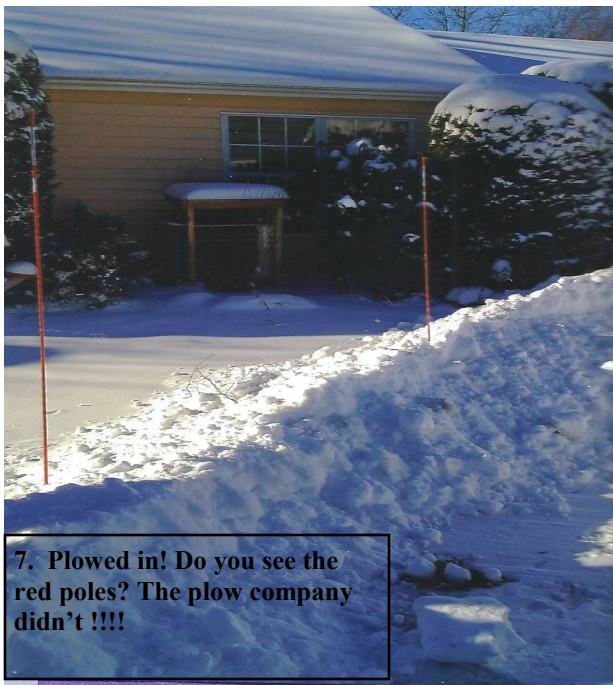
2. 111 Hidden Ridge Drive. Every week we had to dig in to get into our house.

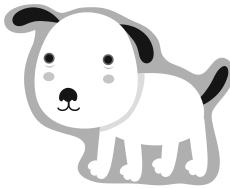

DOG REGISTRATION

At the 2012 Annual Meeting the following rules concerning dogs were accepted by the membership. All residents (owners and renters) are to adhere to the following:



- Homeowners and renters are to register their dogs (including service dogs as well as those visiting for a short time) with the homeowners association and provide proof of current rabies vaccination. Please send this information to the office.
- All dogs residing in Hidden Ridge for a period of 30 consecutive days must also be registered and licensed in the Town of Thompson. Proof of this license must be presented to the homeowners association. All homeowners shall provide proof the dog is licensed in the jurisdiction in which the dog's primary residence is maintained, if the dog does not reside for a period of 30 consecutive days in Hidden Ridge.
- Dog owners are responsible for abiding by the regulations set forth by the Town of Thompson which includes picking up after their dog, walking dogs on leashes, avoiding excessive barking, etc.
- There is a limit of 2 dogs per unit. If you have more than two dogs you MAY NOT replace the extra dog(s) as you lose them.

Results of Tax Grievances for 2014

Sixty-nine (69) Hidden Ridgers filed tax grievances to have the assessed value of their homes lowered. Here are the results:

- First time grievors were asked (by the new Town Assessor) if they would sign a stipulation to lower the assessed value of their unit to \$70000 (if the grievance arrived in a timely fashion). Those who signed will now have the assessed value of their homes at \$70,000. 37 homeowners signed a stipulation.
- First time grievors who did not sign and return the stipulation were all denied by the Board of Assessment review as well as those homeowners who were already at \$70000 (or less) from last year. These homeowners have the right to appeal within 30 days the decision of the BAR. There were 32 who were denied - 19 of these were already at \$70,000 or below.

It has been suggested that in the future, the group of Hidden Ridgers have an attorney familiar with tax grievance procedures represent them. Warren Berkowitz volunteered to research to find us the attorney. Individuals will "sign up" with the attorney as a group. When we have more details, all homeowners will be contacted.

Ed Hertz

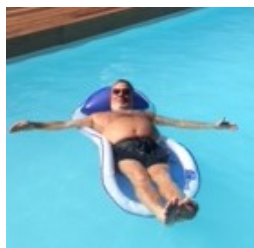
