The President's Message



Dear Hidden Ridgers;

The April issue of the GEM marks for me an ending and a beginning. It marks the winding down of my stay in Florida and the anticipation and excitement in preparing for my return to Hidden Ridge. This year I am more excited than usual – but you can read about that in Linda's column.

The following are a few important items for your consideration:

Winter at Hidden Ridge: Even while enjoying the weather in Florida, I would check the weather in Monticello on a daily basis. I am able to view winter and its harsh elements on the cameras. I watched the snow fall, covering certain shrubs and landmarks on the views that I have available. It was some winter- it seemed that there was one snowstorm after another. I would watch the snow falling, covering everything and then I would see the blacktop reappear due to the valiant efforts of our maintenance crew. I would check in at midnight before retiring and then early in the morning (before 7 AM at times) to see that the men had already started the plowing of our community. That means that they were at work hours before their normal start time to get ahead of the pileup of snow. I was told that they were out plowing at 3 AM during the blizzard of mid March. The guys came in on weekends if there was a snow event to make sure that our residents had a clear path to their cars and to get in and out of the community. Thank you to Mike and the crew for a job well done!

An extra special thank you is owed to Lenny Kirschenbaum for holding down the fort during the week and to Ben Lorick and Robbie Schecter on weekends.

Tax Grievance Update: Several people have called me regarding the status of our tax grievance case. I was even stopped by a resident of Hidden Ridge in the local supermarket in Florida! At the January 17, 2017 meeting of the Town Board of the Town of Thompson, our Tax Certiorari Settlement was discussed. Resolution No. 69 of the year 2017 was passed unanimously. The full resolution can be viewed at http:// www.townofthompson.com/wp-content/uploads/2016/11/TB-Minutes-2017-01-17.pdf. It was next sent to the judge for his signature. He signed on February 23, 2017. At that time it was sent to the Sullivan County Clerk's office. It was recorded on March 2, 2017. According to our attorney, they have 60 days from the time it was filed to respond. At this time, they have less than 30 days left to get the money owed to our attorney. As soon as he receives the bulk funds, he will dispense it out to those who are included in this action. Please be patient!

Gates: Our gates have been in operation since early December 2016. There were minor snags that have been corrected by this time. With the large number of residents coming back to Hidden Ridge this spring, we are reprinting portions of the letter that was sent to all residents in October 2016 (in case you misplaced it) on page 6.

Eating Green (It's in the Bag)

As we look forward to Spring and then, of course, summer, our attention goes to more outdoor time including a recommitment to exercise and healthier "lighter" eating too! All recommended dietary programs, especially for Seniors, such as The Mediterranean Diet or Weight Watchers, etc., emphasize eating less fat (little or no meat) low or little processed foods; less refined carbohydrates, sugars and grains; healthy oils and low fat dairy; plenty of fresh fruit and TONS of greens! The convenience of bagged, pre-washed salad can be a big plus and time saver when it comes to getting ample servings of greens/vegetables every day. But beware...simply put, you must be careful!! Even though bagged/pre-packed salad is washed multiple times, and then sealed, the potential for food illness (salmonella) still exists. The moisture from the plastic bag/plastic container can cause the bacteria to attach to leaves or parts of the veggies. So to ensure safety of your salad and greens follow these simple guidelines:

- 1. Check and HEED "use by" date ----discard at expiration date
- 2. Rinse and Spin dry thoroughly before eating to be extra sure
- 3. Avoid purchasing bags that are puffy or swollen in any way to your eye
- 4. Forgo bags or plastic bowls with crushed, mushy or slimy leaves
- 5. Keep all greens refrigerated !!

EMERGENCY, MAINTENANCE & VENDOR CALL LIST

Many Hidden Ridgers have been calling HOA President, Bonnie Siegel and/or HOA Vice President, Lenny Kirschenbaum with emergency, maintenance and private vendor issues. We have compiled the call list below to assist all residing at Hidden Ridge in directing your calls appropriately. We appreciate your concerns, but your needs will be more quickly and efficiently addressed by calling for emergency services and vendors directly.

1. FOR TRUE EMERGENCIES, CALL 911.

This includes police, fire and medical emergencies. Additionally, you can reach State Police: (845) 292-6600 and the Monticello Sheriff's Office: (845)794-7100.

2. For pest control:

HR has a contract that includes home interior service. Call Liberty Pest Control (845)361-3100 to make arrangements, and be sure to tell them that you are a member of the Hidden Ridge HOA.

3. For TV or internet service:

If your provider is Spectrum (Time Warner Cable) call (855) 707-7382. If you use another provider, your recent bill should have a current phone number.

4. For power issues or outages:

Call NYSEG: (800)572-1131.

5. To report a stray or loose dog:

Call Town of Thompson Dog Control Officer, Nancy Marinchak (845) 796-4237.

6. For Hidden Ridge maintenance issues:

(Cul-de-Sac/street light outage, issues with gutters, retaining walls, general maintenance, etc.) please complete a Maintenance Request Form and place it in the Maintenance Box attached to the bulletin board near Friedman Road entrance.

7. For sewer problems and/or water issues:

THE GATES AT HIDDEN RIDGE

ACCESS INFORMATION:

Old Liberty Road Entrance:

Access can be granted as follows:

Remote control device (see below)

Using your unique access code

Your access code is #_____. This is usually the last four digits of the phone number that is programmed on the telephone access pad (see below) .Please do not give out your access code unnecessarily.

If you do not remember your access code, contact Bonnie Siegel 917-969-9646.

No code or remote is necessary for exiting through this gate.

Please be reminded that the gate is designed to close after each car.

**It is recommended that those of you returning for the first time (without your remote control device) use this entrance

Guest Access can only be through this entrance:

Your guest will scroll to your name on the telephone access pad.

There are instructions on the screen for the telephone access pad. Your guest will scroll the A-Z listing to your last name. There will be a three digit code associated with your last name. Your guest can either enter the three digit code or "Push Call". The dialer will dial the phone number that is listed above.

Upon answering your phone (and speaking to your guest) you will press 9 on that phone and the gate will open.

Friedman Road Entrance:

This is a **resident only entrance**.

You must use the remote control in order to gain entrance into the community.

All vehicles can exit through this gate.

No code or remote is necessary for exiting through this gate.

Please be reminded that the gate is designed to close after each car.

REMOTE CONTROL DEVICES:

Remote Control Devices are the property of the Hidden Ridge Homeowners Association. They will be distributed by Lenny Kirschenbaum (845 794 3395). Winter residents should contact Lenny immediately to obtain your remote control device. Each unit will receive one remote control device. If you need additional devices, there will be a deposit of \$25 per remote. (Make checks payable to Hidden Ridge HOA)

If your vehicle is equipped with **home link**, the remote can be programmed according to the vehicle owner's manual.

Upon **selling** your unit, all remotes must be returned to the HOA. If you acquired a second remote, your \$25 deposit will be refunded. Upon transfer of the property, all remote and access codes will be deactivated.

IMPORTANT INFORMATION FOR OWNERS WHO WILL BE RENTING THEIR UNIT:

Anyone who is **renting** their unit must provide the HOA with a working phone number for the renter so that the renter can be assigned an access code. This must be done at least two weeks before the tenant moves in. They will be assigned their unique access code. Upon arrival at Hidden Ridge the renter will contact Lenny Kirschenbaum (845-794-3395) to obtain their remote control device. All renters will pay a \$25 deposit that will be refunded upon return of the remote. The renter's access code and remote device will be deactivated at the end of the term of the lease.

Please be aware that the several of our regular vendors (US Post Office, UPS, FedEx, Time Warner Cable, etc) have received either a four digit access code or a remote. Emergency personnel will have a siren sensor for access.

FROM THE PEN OF.... Peter Morello



THE SIGN

rom birth to the age of fifteen, I lived in an ancient, broken down chandelier of a building that was nothing more than a tenement built to the building codes of 1913 New York City. Nonetheless, it was our "home" and I had the benefit of

two parents and an older brother who always watched over me – sometimes too much.

The makeup of the neighborhood was primarily Italian with a fair number of Jews and a smattering of Germans and Irish and a little bit of everyone else. Although there were fights now and then, it wasn't because of the different nationalities involved, but more so because someone's child got into a scrape with another child over who knows what. All in all, folks got along well and no family was any better off than the family living next door or in the building adjacent to theirs.

For the first several years of my life, my mother was a stay-at-home mom and when the weather was good and during the summer, we did various things on a day to day basis. It was our custom to go to the "little park" regularly; sometimes every day because it was only one block away. It was called the little park because that's what it was -a very little park. I can't tell you the exact dimensions but it was triangular shaped and was intersected by four streets. It was approximately a half-a-block wide by half-a-block long and had ample benches and was well-shaded by trees providing protection from the summer's intense rays.

It was a place where it was customary to see young mothers with their children allowing them to do what children always do – play with other children and hopefully get tired enough to collapse in the evening freeing their mothers to collapse themselves. On pleasant days you could see several baby carriages dotting the park and it was a safe place to take one's child and no one worried about any harm coming to them. Late in the afternoon the mothers would take the short walk home to prepare dinner for their husbands as they returned from their day's labors. It was a regular routine that both the mothers and children looked forward to and I was no exception. In fact, the story my mother always told me was that the little park was where I caught the mumps. I was two years old and I licked an ice cream cone that another kid was eating who was infected and you can imagine the rest. I was never allowed to forget that story as though I had control over the situation. Any child, I'm sure, will tell you that ice cream comes first – the hell with the mumps.

I clearly remember my neighbors who resided on the second floor where my family lived. Each of the five floors

had four apartments and behind each door was a history: happiness, sadness, health, sickness, fun, discipline, laughter, arguments, love and hate. All of these states of being co -existed in this small tenement where everyone could learn about everyone else's life through the plaster on lather walls without really trying hard to listen. Although, holding a glass against the wall and pressing one's ear firmly against the glass certainly helped.

My next door neighbors were the Santullos. Somehow they managed to shoehorn four girls and one boy into a two bedroom apartment. How they did it I'll never know but all of the children turned out fine with no apparent lingering affects. Their mother, Jean, regularly babysat for me until I was old enough to be given the key to my apartment. My parents were newlyweds when they moved into the building and became quite close to the Santullo family and their children.

Across the hall were the Agunzos. When I was a child their two children were already grown and out of the house. Mike drove a cab while his wife, Helen, stayed at home and dutifully watched soap operas all day long and loved to go to the racetrack when her husband took her. Eating, soap operas and the racetrack is all she needed to be content -Mike did all the housework and bitterly complained about it and his wife's bedraggled appearance but somehow they made it work.

The apartment in between the Agunzos and the Santullos was occupied by Louis Greenberg who was always addressed as "Mr." by my mother and others. He was a widower with grown children who had moved elsewhere.

My earliest memories of Mr. Greenberg were of a man who was slightly built and stood about five foot seven. He was bald and was extremely quiet and spoke softly with accented English. Many times when I was out with my mom, we would meet him in the neighborhood or in the hallway and my mother would always greet him and enter into a brief conversation with him. They would exchange pleasantries and always had a respectful conversation with well-wishes extended by both when parting. Whenever I saw him he would be walking slowly with his head slightly bowed and he seemed to be looking at the ground and would take short, slow steps. He seemed somewhat older than he was and I recently discovered through census records, would have been in his late sixties having been born in 1898 in Austria. He always treated me nicely and would ask how I was and seemed interested in me as a person. It was common for him to comment to my mother that I was a "nice boy." I have no recollection of his wife but I'm sure others in the building knew her when she was alive.

I cannot recollect anyone having a bad thing to say about Mr. Greenberg. I thought it would be difficult to criticize anyone who spoke sparingly and always was respectful and maintained a low profile.

During those years in the summer, I attended the Saint Martin of Tours Day Camp at Saint Martin's Church. It was a way for my parents to keep me off the streets and for me to have some summer fun in a safe environment. By having fun under the auspices of the Catholic Church, no harm could ever come my way – at least that's the way my parents felt and for the most part, nothing bad did happen. We went various places every day during the week and it always involved swimming of some sort and by the time the campers arrived back home, we were too tired to give our parents any trouble and went to sleep dreaming of the next day's impending fun.

It was during one of these summers when I was around eight or nine years old that I saw Mr. Greenberg walking down the street and I noticed he had a tattoo on the inner side of his right forearm. My dad also had a tattoo in the same location that he had gotten during World War II – his was of an eagle. However, I couldn't make out just what the image was on Mr. Greenberg's arm. I saw blue ink but it appeared somewhat faded and didn't seem like a picture of anything in particular unlike the ones servicemen sported which were clearly identifiable.

When I arrived home that evening I thought I would question my mom on this and see what she knew since she seemed to get along well with Mr. Greenberg.

"Mom, I saw Mr. Greenberg today and I noticed he has a tattoo like dad has and..."

"Well, it's not like your father's but yes, it's a tattoo."

"Yeah, I couldn't figure out what it was because it wasn't clear and seemed a little faded and stuff. Did he get it during the war like dad did?"

"No, you see your father got his one evening with some of the other guys when he was in the service, but Mr. Greenberg's tattoo was not voluntary. He actually had to have it," mom responded.

"I don't understand why he has something he didn't want."

I could see my mother wasn't happy with all the questions I was peppering her with. She was trying to prepare dinner before my father arrived home and she had to satisfy his needs and I got the impression she wasn't exactly being forthcoming with me. I was never one to possess good self-control as a child and just had to get the answers I wanted.

"Peter, Mr. Greenberg got his tattoo when he was in the camp many years ago. That's where he met his wife," my mother continued.

"Which camp did he attend? Was it Saint Martin's like I go to? I know it must have been a long time ago and I'm sure...."

"Look, Peter, Mr. Greenberg was in a detention camp that held Jewish people during the time of the reign of Nazi Germany. I know you didn't study this in school yet but this wasn't the kind of camp you attend. This was a prison environment with forced labor and lots of people died and he

and all the other residents received tattoos as a means of identification. His parents and his brother and sister were, ah, were killed during that time. Your father's tattoo is totally different – and do me a favor, the next time you see Mr. Greenberg, don't say anything about his tattoo or mention anything that I've said to you - understand, Mr.?"

I slowly began to understand what my mother was telling me but I could tell by the look on her face and the sound of her voice and her addressing me as "Mr.," that she was serious and perhaps this was a topic that was best left alone by me. I decided not to question her any further but went to bed that night thinking about what she had told me and trying to figure out what this all meant.

Two days later when I was leaving my building to go to day camp, I found myself going down the stairs behind Mr. Greenberg. I caught up to him at the front door and tried to go around him without saying anything, remembering the conversation I had with my mom.

"Peter, why the rush," Mr. Greenberg inquisitively asked.

"Well, I'm a little late, I guess."

"So, you're going to camp?"

I felt panic stricken. Did Mr. Greenberg know what I knew about him? How could that be? How should I answer him and remember what my mother had told me?

"Well, yeah, today they're taking us to Mohansic Park."

"Sounds, like a nice place, Peter. Going to camp must be fun. It would have been so nice if in my time there was a camp I could have gone to but such is life, I guess."

This man actually wanted to go to camp. Why? Didn't he have bad memories from what happened to his family? My nine year old brain was running amok and combined with my fear of Mr. Greenberg finding out what I knew, I couldn't think straight.

"Yeah, I guess you're right, Mr. Greenberg. I gotta go – see you."

"Be well, Peter – you're a nice boy."

Mr. Greenberg went to his right as I went to my left. After taking several steps I slowly turned around. Mr. Greenberg was walking with his head slightly bowed and he was taking short, slow steps as was his custom.

Ever since that day I never looked at Mr. Greenberg in quite the same way. I felt somewhat afraid to say anything to him so as to not let on what I knew. I also felt guilty that I was going to a camp that I thoroughly enjoyed and looked forward to while not even being able to imagine the horrors he must have experienced in his camp...

When my sons and daughter wanted a pet, I immediately reverted to become my parents and wouldn't let them have one. My law firm represented an animal rescue organization and Glenn would take rescued dogs and find a family for them.

One day one of our secretaries said she was leaving because her husband was going into the Marine Corps and they didn't know what to do with their puppy. And that was how Glenn adopted Winnie. She was the sweetest and most lovable dog. Adrienne, who was afraid of dogs, because she was bitten when she was three years old, not only loved Winnie but became a lover of all dogs.

If Glenn couldn't make it up to Hidden Ridge on weekends we would take her up. In fact, if we would visit Glenn, Winnie would leap through the car window, sit by the driver's seat, put her paws on the steering wheel and bark lets go to Hidden Ridge.

While handling an Estate, the family did not know what to do with the decedent's dog. That is how Sophie became part of our family. Glenn bought a house in Hidden Ridge across the road from our house. When Sophie became very sick and Glenn had to take her to the Vet, Sophie started to limp towards our house as if to say goodbye to Adrienne. A little later Winnie also passed away. DOG REGISTRATION

The following rules concerning dogs have been accepted into our documents. All residents (owners and renters) are to adhere to the following:



- Homeowners and renters are to register their dogs (including service dogs as well as those visiting for a short time) with the homeowners association and provide proof of current rabies vaccination. Please send this information to the office.
- All dogs residing in Hidden Ridge for a period of 30 consecutive days must also be registered and licensed in the Town of Thompson. Proof of this license must be presented to the homeowners association. All homeowners shall provide proof the dog is licensed in the jurisdiction in which the dog's primary residence is maintained, if the dog does not reside for a period of 30 consecutive days in Hidden Ridge.
- Dog owners are responsible for abiding by the regulations set forth by the Town of Thompson which includes picking up after their dog, walking dogs on leashes, avoiding excessive barking, etc.
- There is a limit of 2 dogs per unit. If you have more than two dogs you MAY NOT replace the extra dog(s) as you lose them.

Rental Rules at Hidden Ridge

Rental Rules:

1. The homes in our community are to be used for residential purposes only. The Board defines "residential purposes" as including the following:

A home may be deemed to be used for "residential purposes" if said home, or a portion of said home, is leased to one (1) individual or a group of individuals for any period of time up to a maximum of twelve (12) months over a period of eighteen (18) months. The leasing of a home, or portion of a home, for any portion of a given month during the twelve (12) month period referenced herein, shall be deemed leasing for an entire month for the purposes of calculating the aforesaid eighteen (18) month period. All leases will be for one year and non–renewable.

- 2. The rental fee for a twelve (12) month period will be \$1200.
- 3. The rental fee for a summer rental (May October) will be \$500.
- 4. Homeowners who rent their units are to provide to the Homeowners Association a copy of the lease along with the appropriate fees. The lease and the fee are to be sent to the office at least 30 days prior to the occupancy of the tenants. A late fee of \$250 will be assessed to the owner if the rental fee is not paid two weeks prior to occupancy. The homeowner is to complete and submit the rental form along with the lease and appropriate fee.
- 5. In order for the tenant to be able to use the facilities and participate in any HOA activities, all maintenance fees must be current.
- 6. Unit owners are required to hand the keys to the unit and mailbox as well as the *Revised A-Z Booklet* to the renter.
- 7. Units are rented "as is." It is the owner's obligation, not the Homeowners Association to repair and maintain the inside of the unit.
- 8. Unit owners are to provide the HOA with a working phone number for the renter so that the renter can be assigned an access code for the gates. The renter should contact Lenny Kirschenbaum (845-794-3395) to obtain their remote control device. All renters will pay a \$25 deposit that will be refunded upon return of the remote. The renter's access code and remote control device will be deactivated at the end of the term of the lease.






