



## Turning on and off your water to your unit? – Read this first

## Important Information regarding curb valves

Issues have arisen regarding who is responsible for making repairs to broken curb valves. In order to avoid this problem, the Board recommends you use Crystal Water Supply Company Inc. to open the curb valve at the beginning of the season and to close the curb valve at the end of the season.

Please call Allan Schacknovsky at 845-798-5121 to have your curb valve turned on or off. Crystal Water has promised that Allan or its designated representative will turn the curb valve on or off within 48 hours of notice. The cost will be \$50 to open the valve and \$50 to close the valve.

Members are not required to use Crystal Water to open and close the curb valve. However, if you use Crystal Water to open and close your curb valve and the valve is broken, Crystal Water will be responsible for making repairs. If you do not use Crystal Water, you will be responsible for making repairs including calling 1-800-DIG so underground utilities lines can be located, making arrangements for any necessary excavations and paying all costs incurred for the repair of the curb valve.

You may use anyone you want to drain the pipes and the hot water heater inside your unit. If you have any questions, please contact Bonnie Siegel at 917-969-9646 or Fred Hirsh at 516-639-0238.

#### SELLING YOUR UNIT? PLEASE READ THE FOLLOWING

At a recent meeting of the Board of Directors, the following was approved:

The transfer fee on the sale of a unit has been increased to \$2500 on all transfers that take place pursuant to contracts of sale entered into on or after September 15, 2020. The transfer fee is paid by the buyer at the time of closing.

#### MAINTENANCE REQUEST FORMS

ALL requests for exterior maintenance must be written on Maintenance Service Request Forms. Use one form per request. Forms submitted with more than one item on it, will be returned for revision to the homeowner. Copies may be picked up in the pocket envelope on the bulletin board. All requests should be placed in the maintenance mailbox on the right side of the main bulletin board.

## A NOTE REGARDING OUR GARBAGE DUMPSTERS

All residents of Hidden Ridge are reminded that garbage is collected on Tuesday and Friday. Household garbage only must be placed in the dumpsters. ## FROM THE PEN OF.... Peter Morello



#### **AT THIRTEEN - PART 2**

The following is the first in a series of stories detailing the important events in my life from the ages of 13 to 17 as I remember them. These are the memories that I regard with both fondness and a bit of sadness which have impacted in various ways and have stayed with me into adulthood. It is



my sincerest wish that you enjoy these stories as much as I have enjoyed writing them for you....

s the summer approached my mother set about doing what she thought was best for me; to place me in the Mount Carmel Day Camp for another fun-filled summer. She was quite dismayed and upset that I was rejected by the camp director, Pat Ruvo, because I was thirteen and the cutoff was twelve. I was in the kitchen when mom was pleading with Pat over the phone and said I should not be penalized because I was a "January baby" and what are a few months either way. Pat was very resistant at first but after listening to my mother's pleadings, he relented and I was able to go once more to a place I truly loved and didn't have to hang out in the streets which was why my mother was so persistent.

Day camp was a blast and we went to a lot of fun places including the opening day when we went to Rye Playland and spent all afternoon going on every ride we could within the time allotted. I didn't realize at the time how lucky of a kid I was to be able to go to day camp or the financial struggles my parents faced to send me there. Those summers occupy a place in my memory that can never be dislodged.

Midway through the summer I was summoned to the office of Pat by one of the counselors. He told me I was in trouble and although I couldn't figure out why, I began to panic. I began to wonder if mom was going to give me a left hook or a right cross because I was causing a problem after she fought so hard to get me accepted for one last summer.

When I entered Pat's office, he could see the look of fear on my face and the look on his face was serious. "Peter, I was just speaking to some of the counselors about you and I wanted to speak to you about something important. Would you be interested in being a C.I.T.?" I knew immediately what this conversation was about. He was making me an offer to be a "counselor in training" and I would be able to go to camp for free while learning the ropes and would have a paid position once I turned fifteen. I was also relieved that I wasn't in any trouble.

I accepted the offer without hesitation and couldn't wait to get home to tell my parents. My mother was not only happy for me but seemed greatly relieved that she wouldn't have to worry about what to do with me next summer. I'm also sure she was happy about the savings. Even in those days, day camp was a financial burden for families of modest means which was the profile of the typical camper. As for my father, I told him the good news while he was eating dinner and he said, "Good," without

missing a forkful of food.

During the summer, I went with dad to a local bookstore and I was looking for whatever books were available to study for the specialized high school exam. It didn't take long to find a book that was perfect – it was a thick book from Barron's that gave the student everything they needed including mock exams. It cost two dollars and as soon as I got home, I eagerly opened the book and began from the first page not wanting to miss anything that may have been important.

As the summer wore on, I alternated studying with attending day camp and was a happy camper in general. I was still living in Belmont and the enclave I lived in, which was on the neighborhood's periphery, was rapidly changing and becoming increasingly dangerous. I knew several families who had moved three years before to the newly built Co-op City just a few miles away. I began to realize that things would never be the same in the neighborhood where I was born and that the lifestyle, I was experiencing was fast becoming a memory. My brother had left in December 1970 when he got married and moved to Queens where his bride lived. We could only do better in life and knew that entailed permanently leaving our little tenement where my parents moved to as newlyweds in January 1945 and where both my brother and I were born.

In September it was off to ninth grade and hopefully new adventures. This proved to be a defining school year for me – I was studying the much-dreaded algebra and was two months away from the big test. Although I was concentrating on my studies, I was also putting in overtime preparing for the entrance exam.

November arrived and even though my thoughts were transfixed on Thanksgiving, I was nervously awaiting Saturday the 13<sup>th</sup> when I would have to go to Bronx Science to take the test.

I remember feeling intimated at the large entry way leading up to the school and wondered if this was going to be the only time I would walk through the green entry doors. The test was pretty much as I expected but I was not confident that I had done well enough to achieve a passing grade for that year's crop of applicants. I knew the competition would probably be stiff and I truly hoped for the best outcome.

When I got back to school on Monday, Zucker was bragging to our science teacher, Carol Shepis, that the test was "easy," and he remarked he had breezed through the exam. He continued that he was not stumped by any of the questions and felt it may have been a bit too easy.

I disliked this kid even more now but was sure he had scored high enough to outscore any of the other kids in the class who sat for the exam. I really wished I had his confidence.

The end of the year rapidly approached and I was soon to be fourteen and at least a little bit closer to being a man

#### A Notice to our residents returning to **Hidden Ridge**

As we approach the halfway point for the summer it is important that we reflect on the challenges of the winter and spring not only here at Hidden Ridge but throughout the state, nation, and the world. The Covid-19 pandemic has truly turned our world upside down creating new norms in terms of our behaviors and most importantly how we interact with each other to insure our individual and community health and safety.

New York State endured some very dark and challenging days, but we proved to be New York strong taking the tough measures to turn the tide in this state and region. Unfortunately, this was not true through out the country and many – too many – states and regions are now facing a similar if not a worse crisis.

In order to maintain New York's gains in mitigating the impact of the virus, the Governor has enacted an executive order that requires that ALL individuals, with some exemptions for essential workers, who arrive in New York State from designated states MUST self-quarantine for 14 days after leaving those states.

#### Specifically:

- Self-quarantine requires that individuals remain in their "quarters"
- Those in quarantine may not venture out in public except to attend to medical appointments that can not be rescheduled.
- They cannot walk or stroll the grounds of the development.
- Food must be delivered to their doors without face to face interaction.

The Health Department encourages residents of the state to report suspected violations. There are financial and other penalties for failure to follow these regulations.

#### SEWERS AND WATER CLARIFICATION

There is confusion among our members regarding the water and sewer charges. Hopefully, this will help you understand these charges.

#### **SEWER**

Every member of the HOA is required to pay a \$400 annual sewer fee. The sewer fee is payable once a year in August. You should receive a bill directly from Sullivan Infra West for the sewer fee.

#### WATER

As of September 2020, each unit owner will be billed individually by Crystal Water Supply Company Inc. for water. The HOA is providing Crystal Water with the mailing address of each member so that Crystal Water can bill the members directly.

The HOA has been collecting \$25 per month from each member to pay the water fee for each unit. This was collected by the HOA as an accommodation to Crystal Water Supply Company, Inc.

The HOA was not required to collect the water fee. In fact, the tariff approved by the New York State Department of Public Service provides for Crystal Water to bill each unit owner a water fee of \$74.67 per quarter retroactively.

In June 2020, the New York State Public Service Commission approved a surcharge to cover the cost of repairs made to the water system in 2019. Under the provisions of this order, Crystal Water is permitted to charge each member \$22.59 for 8 consecutive quarterly billing periods to recover the cost of the repairs.

After the repair charges have been recovered, Crystal Water is permitted to charge each member up to \$17 per quarterly billing period until it has received \$10,000 to create an escrow fund to cover the cost of future repairs.

The HOA has collected the water fees due for July and August 2020 as part of the monthly HOA fee. Based upon the tariff and the surcharge, each member should be receiving a bill from Crystal Water in October 2020 in the sum \$47.48 consisting of \$24.89 water charge for September 2020 and the \$22.59 for a surcharge.

Each member should receive a bill from Crystal Water in January, April, July and October 2021 and January, April, and July 2022 in the sum \$97.26 consisting of the quarterly water fee of \$74.67 and the surcharge of \$22.59.

Each member should receive a bill from Crystal Water in October 2022 and January, April, and July 2023 in the sum of \$91.67 consisting of a water fee of \$74.67 and a surcharge of \$17.00.

Thereafter, each member should receive a quarterly bill for the water in the sum of \$74.67 unless the Public Service Commission approves an increase in the water fee or any additional surcharges.

The payment of this bill should be sent to Crystal Water at the address designated by Crystal Water for the payment of the bill.

Should you fail to pay your water bill, Crystal Water has the right, upon notice as required by law, to turn off your water service.






